To forge positive relationships between home and school and to support the education of your child, it is important for families, children and their teacher to meet and discuss your child's wellbeing, celebrate their achievements and discuss the areas which they can focus on developing.

As Duty Bearers, we are duty bound to include children in matters affecting them. Therefore, the children are invited to attend the parent/carer consultation with you. We are sure you will find having your child attend the consultation really beneficial as it will help them understand what they have done well and what their next steps are to improve further.

All parents and carers must book their child's parent/ carer consultation using the School Spider app under the 'Parent's Evening' tab. These will go live on Thursday 21st November at 17:00. Please note, once these are booked, these cannot be changed after Monday 25th November at 17:00.

As an inclusive school, we would like all children with SEND to have the same experience at parents evening as those children who do not have SEND. Families who have a child with SEND are invited to book an appointment during these evenings. At this appointment, your child's class teacher will include a review of your child's last Access to Learning plan targets. New targets will then be set by the class teacher and you will be able to comment on these on Edukey.



All Parents and Carers consultations will take place in your child's classroom. All parents and carers should enter school through the main entrance at the First School. The children's entrance and exit doors will not be in use. At your consultation, you will be given your family's data collection sheet to check and amend, you are welcome to take these home and return them to school the next day, or you can hand them in to the member of staff in the main office on your way out.
